# Assist in the development of the 2021 HIV estimates in MENA countries TERMS OF REFERENCE December 1, 2020 - April 30, 2021

## **BACKGROUND/PURPOSE OF ASSIGNMENT:**

The purpose of this contract is to assist a lead consultant in supporting countries in the Middle East and north Africa in the development of regional and national 2021 HIV estimates using the UNAIDS Spectrum software tool. For more details on the HIV estimates and the Spectrum software tool, please see: UNAIDS Reference Group on Estimates, Modelling and Projections. (www.epidem.org).

The role of the junior assistant in supporting countries to develop their 2021 HIV estimates is as follows:

- 1. Participate in a facilitator's training workshop to learn about the Spectrum software.
- 2. Assist countries in preparing data inputs for use in the Spectrum model with support from the lead consultant.
- 3. Participate in webinars (in English and French) to assist countries in using the software.
- 4. With support from the lead consultant and the UNAIDS focal point, directly assist selected country teams as assigned by the lead consultant to incorporate new programme and surveillance data into the model, run the model, review and finalize key results with the country for publication.

Throughout the working period, the consultant should be available to work closely with the lead consultant and UNAID focal points to respond to country and UNAIDS questions about model results prior to finalization on April 30, 2021

#### **REQUIRED AND DESIRED SKILLSET**

The contractor shall be able to demonstrate through their CV and a cover letter the following skills:

- 1. Three or more years of experience working with health programme, survey and/or surveillance data or monitoring and evaluation activities in one or more countries in the MENA region (REQUIRED 40 points). Experience specifically in STI/HIV monitoring and evaluation or programmes an asset (DESIRED)
- 2. Proven analytical skills and experience in analysis of health data, as demonstrated by contributions to reports, journal articles, publications, or other grey literature (REQUIRED 30 points). Experience specifically in STI/HIV monitoring and evaluation or programmes an asset (DESIRED)
- Good scientific writing and communication skills in English (REQUIRED) with French or Arabic an asset (DESIRED) (15 points)
- 4. Demonstration of project management skills, including excellent consultative and organization skills (REQUIRED) (15 points)

### **WORKING HOURS AND EXPECTED DELIVERABLES**

The expected contract duration is 30 working days between December 1 to April 30, 2021. The contract deliverables include the following:

- 1. December 2020 Participate in training workshops to learn about the Spectrum software (2 days exact dates to be determined).
- 2. January 17-21, 2021 Work with selected countries to prepare data for entry into Spectrum prior to the training workshop (3 days)
- 3. January 24-28, 2021- Serve as a facilitator/technical resource person during online training sessions (3 days)
- 4. January 31- February 15, 2021 Assist the lead consultant in the production of three to four page review of the country's draft estimates to be shared with the country (9 days)
- 5. February 15-28, 2021 Support the estimates MENA core team in responding to country and UNAIDS questions about model results prior to finalization on February 28 2021 (8 days)
- 6. February 28-April 30, 2021 Provide additional analytic support to UNAIDS HQ, the MENA region and the lead consultant to resolve outstanding queries on national estimates (6 days).
- 7. Provide a financial report describing the work performed and the corresponding person-hours by May 30, 2021

Technical oversight of the work will be done by Ian Wanyeki, Epidemiologist at UNAIDS in the Strategic Information Department in Geneva, Switzerland and Dr. Ranga Gurumurthy, ai, MENA RST, UNAIDS. Mr Wanyeki will initiate correspondence between the successful bidder and country representatives to facilitate completion of the task.
